## TERMS OF APPOINTMENT

The position is a temporary fixed-term contract, part-time and is subject to a minimum employment period of 6 months from the date of commencement.

## POSITION PURPOSE

The Woodwind Specialist's responsibility is to guide the pedagogical development of the woodwind students in the Instrumental Tuition Program and Co-Curricular Music program in Middle School (Years 5-6) at Newhaven College. As a member of the Music team at Newhaven, the Woodwind Specialist will provide leadership to staff working with students playing woodwind instruments and assist the Director of Music in the development and attainment of teaching and learning goals across the program. The Woodwind Specialist will encourage students to participate in music opportunities at the College by engaging students at their ability level and providing appropriate challenges to inspire personal and musical growth.

# Responsibilities and Accountabilities

## STUDENTS

The Woodwind Specialist will assist the Director of Music to:

- Develop a personal knowledge of each woodwind student within the Individual Music Tuition Program and liaise with parents, support and teaching staff concerning the progress of students in their academic and instrumental music pursuits.
- Make recommendations regarding ensemble involvement and positioning of students enrolled in the Ensemble Program.
- Assist in developing processes to track and monitor student progress.
- Collaborate in the analysis of collected data to reflect upon and refine pedagogical approaches across the department.

## STAFF

The Woodwind Specialist in cooperation with the Director of Music will:

- Lead and work with instrumental music teachers and tutors to develop and refine their pedagogical approaches.
- Guide and support instrumental music teachers and tutors in working with individual students.
- Assist in the allocation of students to teachers and collaborate with the leadership group in decisions regarding timetabling and teaching allocations.



## PARENTS

The Woodwind Specialist will assist the Director of Music to:

- Encourage parental support of their students.
- Provide information parents need to support and encourage student participation in the Ensemble Program at Newhaven Music.

## COMMUNICATION

Through the Director of Music, the Woodwind Specialist is responsible for:

- Keeping the College Leadership Team aware of issues that call for a whole school response as well as specific issues arising within the instrumental music department.
- Communication with parents regarding student progress and attendance.
- Participate in the monitoring and quality assurance of reporting processes utilised within the Instrumental Music Department.

Have the ability and preparedness to work outside normal hours when required.

## STUDENT LEARNING

The Woodwind Specialist is required to:

- Develop partnerships with the other members of staff within the Music Department and the broader College environment.
- Contribute to a culture of continual improvement of teaching and learning by modelling and encouraging contemporary pedagogy, professional development, peer observation and effective classroom practices.
- Liaise with music staff to develop and support learning outcomes for students of all abilities.
- Undertake teaching duties as required by the Principal or Director of Music.
